Candidates **failing** in written test according to the norms set by University Grants Commission would not be called for VIVA-VOCE.

PhD entrance test (PET) Viva-Voce—(Date—07-12-2023). Viva-Voce will be held for applicants (i) who qualify the written test to be held on 06-12-2023 and (ii) the written test exempted applicants having JRF (UGC,CSIR etc). as indicated in University Grants Commission (Minimum Standards and Procedure for Award of M.PHIL./PH.D Degrees) Regulations, 2022 and prospectus-2023(Revised).

** Candidates not qualifying written test will not be called for Viva.

Modalities to be followed by the applicants for appearing in Viva-voce

- 1) All applicants to be appearing in viva are directed to prepare their research proposals (within 1500 words) and submit the same on the date of viva-voce or else they will **not be considered for admission**.
- 2) Research proposal to be submitted should be of the **standard** form comprising all the important features and have to be submitted **compulsorily**.
